1. After the establishment of a credit account between the Applicant and the Company, the terms of this Agreement shall govern the relationship between Applicant and Company, and Guarantor, if applicable.
2. All invoices are to be paid within 30 days from the date of the invoice. Invoices outstanding after 30 days shall be deemed delinquent, and shall accrue interest at the rate of 1.5% per month until paid in full. The company shall be entitled to recover from the Applicant (and the Guarantor, if applicable) reasonable attorney's fees and suit if the account becomes delinquent and is referred to collection.
3. Any claims or disputes arising from invoices must be raised within seven working days from the invoice date and must be made by written notice to **Magic Technologies, Inc.** outlining the disputed amount or claim. Legitimately disputed invoices do not accrue interest until the issue is resolved.
4. By submitting this application, you authorize **Magic Technologies, Inc.** to make inquiries into the banking and business/trade references that you have supplied, and to obtain your credit report from time to time as long as the account is open.
5. By signing this application, the Applicant entity is agreeing to the terms and conditions set forth in this Agreement.

**Personal Guaranty**

The Applicant and Personal Guarantor further agree that the venue for any litigation arising from or filed in connection with this Agreement shall be in Orange County, Florida.
